

**CORTEZ**  
**SANITATION AND SOCIAL DISTANCING POLICY**  
**THIS POLICY IS INTENDED TO MINIMIZE THE SPREAD**  
**OF COVID-19**

1. ALL PASSENGERS WILL SIGN AN ACKNOWLEDGEMENT OF RISK, WHICH INCLUDES A QUESTIONNAIRE ON PRESENT HEALTH REGARDING COVID-19 SYMPTOMS.
2. ALL PASSENGERS AND CREW WILL WEAR MASKS. PASSENGERS TO BRING THEIR OWN MASK.
3. PASSENGERS TO BRING THEIR OWN PILLOW.
4. BERTHING – ALL COMFORTERS AND SHEETS WILL BE WASHED AFTER EVERY TRIP.
5. ENTIRE STATEROOM WILL BE DISINFECTED AFTER EVERY TRIP.
6. AIR CONDITIONING FILTERS WILL BE REPLACED AFTER EVERY TRIP.
7. HALLWAYS WILL BE DISINFECTED AFTER EVERY TRIP.
8. RESTROOMS WILL BE DISINFECTED 10 TIMES DAILY, IN A 24 HOUR PERIOD (5 TIMES DURING DAYLIGHT HOURS AND 5 TIMES DURING NIGHT HOURS). SPRAY BOTTLE OF DISINFECTANT AVAILABLE 24 HOURS A DAY FOR PASSENGERS USE.
9. GALLEY TABLES DISINFECTED AFTER EVERY MEAL. GALLEY STAFF WILL BE WEARING GLOVES AND MASKS.
10. ALL GALLEY SUPPLIES IN BOXES AND CANS WILL BE DISINFECTED BEFORE LOADING ONTO BOAT.
11. ALL FOOD WILL BE SERVED, INCLUDING HORS D'OEUVRES. ALL COOKIES & SWEETS WILL BE INDIVIDUALLY WRAPPED.
12. ALL HANDRAILS AND FLAT SURFACES ON DECK TO BE DISINFECTED TWICE DAILY. ENTIRE BOAT SCRUBBED WITH BLEACH & SOAP AFTER EACH TRIP.
13. ALL PASSENGERS ARE RESPONSIBLE FOR SOCIAL DISTANCING, WASHING HANDS REGULARLY AND WEARING MASKS.
14. ALL PASSENGERS ARE RESPONSIBLE FOR STAYING OFF THE BOAT IF THEY ARE EXPERIENCING ANY SIGNS ASSOCIATED WITH HEALTH DEPARTMENT GUIDELINES FOR COVID-19.
15. ALL PASSENGERS ADVISED PRIOR TO BOARDING RE: SAFETY MEASURES FOR COVID-19 ALONG WITH NORMAL COAST GUARD REGULATIONS.
16. PLEASE UNDERSTAND IT IS THE INDIVIDUAL PASSENGER'S RESPONSIBILITY TO TAKE PERSONAL PRECAUTIONARY MEASURES.
17. ALL CREW WILL BE SCREENED AS TO PRESENT HEALTH BEFORE DEPARTURE.

# CREW TRAINING

1. Every crew member has read & understands our re-opening plan.
2. Sanitization of the vessel, all surfaces and railings will be our top priority.
3. If there is a passenger who indicates they are feeling sick, running a fever or has any symptoms of Covid-19, will immediately report it to the Captain.
4. Galley Crew are aware of the importance of wearing gloves and masks while working in the galley.
5. Crew will wear masks at all times when interacting with passengers.
6. Crew will advise passengers to keep social distancing of 6'.
7. Crew has been instructed that if they have a fever or have been in contact with any person who has tested Positive for Covid-19, they should not come to work.
8. Soon after boarding, there will be a seminar going over all safety factors, including where all sanitizer spray bottles will be available.
9. Crew will be taking temperatures of all passengers



# COVID-19

DO NOT BOARD THE BOAT IF YOU  
HAVE THE FOLLOWING SYMPTOMS:

COUGH, SHORTNESS OF BREATH,  
DIFFICULTY BREATHING, FEVER,  
MUSCLE PAIN, HEADACHE, CHILLS,  
SORE THROAT, OR ANY OTHER  
SYMPTOMS ASSOCIATED WITH  
COVID-19.

EVERY PASSENGER AND CREW  
MEMBER MUST PRACTICE SOCIAL  
DISTANCING BY STAYING AT LEAST 6  
FEET APART. ANY TIME THAT  
SOCIAL DISTANCING IS  
TEMPORARILY NOT POSSIBLE, A  
MASK MUST BE WORN.
